



## WCR North Shore Chapter 2008 Member of the Year Award Qualifications and Guidelines

**The Awards shall be for the year in which it is presented and shall be presented at the December General Membership Luncheon and Meeting.**

Request for Nominations shall be made to the General Membership no later than September 5. The deadline for Nominations shall be September 15, after which the Recognition and Awards Committee shall meet to select the award winners for that year.

The North Shore Chapter shall accept nominations for Realtor® and Affiliate nominees and shall present awards to the **Realtor® Member of the Year** and **Affiliate Member of the Year**.

**Eligible Realtor® Nominees** shall be a current member of the National WCR for a minimum of five (5) consecutive years. Current Officers shall be ineligible to receive the award during or within one year after the term of office.

**Eligible Affiliate Nominees** shall be a current National Affiliate or Local Affiliate member of the North Shore Chapter for a minimum of two (2) consecutive years and shall have served the Chapter by participation in Chapter Committees, functions and/or planning.

- The Chair and Co-Chair of the current year's Awards & Recognition Committee shall be the prior year's recipients of the awards.
- The Local Chapter President shall appoint the committee members.
- It is recommended that prior award recipients be selected as committee members when possible.
- The Committee shall consist of not more than five (5) members and no fewer than three (3) members.
- Three (3) members shall constitute a quorum.
